June 2026 Board Meeting

PRESENT: Ed Zebrowski, Allan Kintz, Chuck Dobbs, Cheryl Zebrowski, Greg Cliburn, Pauline Colbey, Kyle Colbey, Dave Colbey, Bob Gillespie, Rob Craig

CALL TO ORDER: 7:02 pm

MOTION: Kyle, Greg: Accept May minutes as presented. CARRIED.

TREASURER: Investment account at \$105k, Meddaugh investments at \$392k. Checking account at \$91k after the Sprints income. Will need to eventually consider how much to move back to investments (if at all). Initial estimate based on checking account math is that we may have been close to break even on the Sprints event.

MEMBERSHIP: 263 this month. This month showing 15 expired - which is unusually high. Will see what happens next month with the total.

ACTIVITIES: Will start looking into Annual Meeting planning. Expect the date to be 11/21 (third Saturday in November).

WEBSITE: Race results and minutes have been uploaded. Waiting on Time Trial results separately - Kyle to send. Have also added Solo registration links for the season.

GREEN GRAND PRIX: No planning currently happening yet. Looking to see about potential additional sponsors for next year - maybe BAE. Will investigate further with usual fall planning.

CLUB RACING: Event overall seemed very successful. Time Trials groups in particular were very pleased and thankful. Waiting on final invoices from WGI for overtime/damage - but at the moment, may have a ~\$500 surplus. TT groups advised that if we can decide soon enough for next year, they could add our event as a "points" event for their season and that could potentially increase entries.

SOLO: First Glen-hosted event was this past Sunday at CCC. Overall good event, especially considering the weather forecast with thunderstorms threatening in the afternoon. Even with that, still had 28 entries including a few first timers. Did not end up with as many runs as hoped - but more due to trying to finish before the storm hit than any major issues. The lot surface did present its usual challenges with some areas continuing to deteriorate. Did introduce new trophy decals as a pseudo-replacement for the old dash plaques and trophies. Seemed well received. Also new helmet stickers to easily identify helmet years. All in, including purchases for new forms, wristbands, etc, expect to be a few hundred \$\$ positive for the event. Next event is July 12 at Arnot Mall.

RE LAPTOP: Replacement has been purchased. Allan to hand off to Ed this weekend at some point during the Super Tour.

REGION BANKING: Need to get Rob Craig his own debit card for regional spending with the Solo program. More than enough region-related purchases to justify having his own card.

MOTION: Kyle, Greg: Approve Rob Craig to receive Glen Region debit card. CARRIED.

SUPER TOUR: Thought has been brought up to discuss potential of changing annual Super Tour event into a Majors event knowing that Central Florida has made this change in the past. May need to reach out to CF region to learn more about their reasoning and what led to the change. Kyle notes that other Majors in the division do not necessarily perform well within the division. So we'll need to consider that also. Chuck notes discussion with

Terri about younger drivers potentially not considering WGI a "destination" track or not necessarily knowing the history that drives that. Any serious discussion should also include Charlie Tanck and Mike Toombs from a FLR and national board perspectives.

DONATION REQUEST: Received a request from IMRRC for a \$10k donation for a "History with Bill" video series. Specifically to be funded from the Meddaugh account. Region discussed and voted over email given the timing and deadlines and timing of board meetings. Motion passed by email votes. Greg to coordinate payment.
