CALL TO ORDER: 7:01 pm

MOTION: Chuck, Kyle: Accept September minutes as presented. CARRIED.

TREASURER'S REPORT: Over \$577k in investments (mostly Meddaugh account). Checking at \$11k. No significant expenses upcoming, so we will leave a small amount in checking for the winter.

MEMBERSHIP: Membership currently stable at 269 - a few expired and some new members.

ACTIVITIES: Annual meeting is scheduled and everything is in place for November 15 at 7pm. A reminder that the awards banquet is Saturday, January 17 at the Radisson in Corning.

WEBSITE: No major updates. All solo events and points have been posted.

OLD BUSINESS: Larry Emery's celebration of life was October 11th. There was a good turnout with many from the SCCA in attendance.

CLUB RACING (2026): The Glen Region has a tentative date of May 30-31, 2026 for our only event (regional). The event will be a double divisional. There are some different ideas about how to format the event. There is a potential for an outside race series to join us. A time trial group (or groups) mixed in with the race groups could be another possibility. FLR's Fun One from 2025 had time trial groups, and the region can use feedback from that event to help us decide on a format.

SOLO: Corning Community College was October 5th. It had 26 entries and no issues were noted. Watkins Glen was the last event of the season, on October 19th. There was an insurance incident in this event. The use of electric scooters was discussed in broad terms, but no decisions were made. The board discussed a hypothetical of restricting access of member(s) to our events, but no motions or actions resulted from the conversation.

SUBCOMMITTEES: Dallas has not made progress. He is currently re-evaluating what his ability will be to support these groups because he wants to make sure that the region is making progress on both topics (use of the Meddaugh estate and growing/ sustaining our region)

ELECTIONS: SCCA Area 10 Board of Directors is running unopposed; Chuck Dobbs will represent our area for another term. The region will tally votes for our board next month at the annual meeting, November 15th.

MOTION: Chuck, Cheryl: Approve 1 \$500 education grant with the winner to be drawn at the annual meeting.

NEW BUSINESS: The Green Grand Prix is April 10, 2026. Anyone that would like to volunteer to run the event is welcomed. The event is currently working on sponsors, tie-ins with other organizations, and a schedule.
