CALL TO ORDER: 7:00 pm

MOTION: Chuck, Kyle: Approve December minutes as presented. CARRIED.

CORRESPONDENCE: Had sent letter and note to new owners of former Meddaugh property to try to recover electricity charges before the account had been changed. That letter was returned undeliverable and the property appears to be up for sale again already. Not expecting to recover that money (probably a few hundred dollars).

TREASURER: \$179k in regular investment account and \$397k in Meddaugh account. Currently about \$10k in checking. Will need to make a transfer to pay upcoming track deposit for Sprints.

MEMBERSHIP: Currently 263. One new or renewed and 4 expired.

ACTIVITIES: Awards Banquet held this past weekend. Had some good feedback on the venue and menu. May look to do the same location/style again next year. Had 41 attend. Presented awards this past weekend for 2025 season. Majors/Super Tour award presented to John Hellmers. Worker of the Year went to Dave Cole. Service Award (from the RE) presented to Allan Kintz.

TOM BURKE AWARD: Glen Region again presented with award from national office for medium regions. Have won a number of times in recent years.

WEBSITE: No major updates. Minutes have been uploaded as they've been sent. May have a few personnel updates to make on specialties. Chuck will be sending a list of changes to Dave.

GREEN GRAND PRIX: MCC will be attending with some students but no car. Toyota has also been confirmed again as a title sponsor.

CLUB RACE: Contracts have been received and reviewed with a couple modifications. Likely to be sent in with deposit soon. Did learn from track that most customers are not actually using the track tickets from the contract - we will likely still get a selection of them for this year. Have contracts for Sprints - will be \$78k - likely minus camping fees - still confirming. Working on supps for race and for time trials. Will be running 5 race groups, FVCC, and time trials (no novice TT). Also in communication with FST group that may be able to bring 10 or 11 cars - would like to have a split start but will depend on number of cars in that group overall.

SOLO: Will not be running at Chemung Speedrome in 2026 (track is also for sale). Expect Shangri-La track to take its place. A preliminary schedule has been created but not finalized. Will be looking into Corning Big Flats plant lot again. Now need to have course design training starting this year - eventually safety stewards will also need to have completed this. Per Mike T. this is a fairly standard online class like some of the other SCCA online trainings.

NEDIV DIVISIONAL MEETING: Scheduled for 2/21, currently on MSR for registration.

NATIONAL CONVENTION: Currently running, still able to sign up and take live courses. Others to be available as recordings.
